

British Air Power demonstrates how the Royal Air Force sought to adapt in regard to the roles it could play and the conflicts in which it could be used, as well as the evolution of air power doctrine at a time of rapid changes in national politics and in the international arena. 

In the second decade of the 21st century, the Philippine terrorist organisation the Abu Sayyaf, predominately domiciled in the southern Philippines, added a new dimension to their kidnap-for ransom enterprise — piracy. Accompanied by kidnap-for-ransom as opposed to traditional piracy which, in the main, this involved the robbery of an ocean-going vessel's crew, cargo, or even the vessel itself.

The Abu Sayyaf has been in existence in some form or another for over a quarter of a century in the greater Mindanao region of the southern Philippines. Originally formed with the intention of creating an independent Muslim State in the southern Philippines, it has degenerated into a number of sub-groups whose sole endeavour is now kidnap-for-profit, accompanied in many instances—if a ransom is not paid—by beheading of the kidnap victims.

Flush with funds, the various groups were able to purchase small fast-moving vessels and embarked on piracy in the greater Sulu and Celebes Seas region. This publication focuses on the "explosion" of Abu Sayyaf piracy in the region in 2016 and 2017.

• Even though nations have been dispatching air advisory missions to other states for more than a century, this remains an understudied field. Using historical case studies, this book examines these efforts in order to provide a framework for evaluating the challenges and opportunities inherent in such missions.

The increased focus on counterinsurgency warfare and US nation building efforts after the attacks of 11 September 2001 reignited interest in military advising within military and other government organizations, private think tanks, and defense related contractors. Most studies on the subject, based on the chronological scope and numerical preponderance of ground advising missions, has quite naturally focused on these past efforts. Less attention has been given to air or naval advisory missions. This work seeks in part to help redress this current imbalance by examining a number of historical case studies dealing with air advisory efforts. By examining a number of historical case studies, this volume analyzes the challenges and opportunities inherent in aerial advisory efforts and offers insights into the methods by which such missions succeed or fail. Air advisory missions date almost to the first days of powered flight.

Air advisory efforts have a number of unique elements based on the fundamental role of advanced technology and the extensive resource requirements associated with aviation operations. For example, air advisory efforts are profoundly influenced by the types of aircraft involved and the types of mission flown. Likewise, the issues of maintenance support and the infrastructure needed for these missions plays a key role in determining capabilities available to the host nation. In the case of infrastructure, airfields, fuelling depots, maintenance and repair facilities, and radar and communications equipment offer a few of the most obvious requirements to support flight operations.

The early history of advisory efforts reveal issues that remain relevant today, including questions related to the nature of aerial technology to be shared, the type of training to be provided, and the potential economic benefits that might accrue to the donor nation as a result of the sale of aviation technology to the host country. In many respects, air advisory efforts raise a number of profound strategic questions for the donor nation. Among others, these questions relate to the type of technology to be shared, the nature of training to be given, the role of foreign advisors in operations, the issue of infrastructure development and auxiliary training programs, the preparation of foreign advisors for their duties, and perhaps most significantly the development of the type of capabilities required to address the host nation's security environment. Via a series of historical case studies, this volume explores these questions and others.

The armed forces of the Republic of China (ROC) on Taiwan are in dire need of reform to address a plethora of problems including inadequate training, low morale, poor public perception, and low recruitment numbers. 



Ten years have elapsed since the fall of the Berlin Wall, which served as a fitting symbol for the end of the Cold War. That historic juncture brought into question the main edifice of western European security arrangements - the North Atlantic Treaty Organization - that had served Alliance members so well since NATO's founding in 1949. It also brought into question the rationale for America's continued deep involvement in European security affairs.

With the gradual realization that the Russian menace is essentially dead, at least for the next 10 to 15 years and perhaps longer, and with NATO's missions having evolved well beyond the original purpose of territorial defense, debate on both sides of the Atlantic has begun to intensify concerning the vital issue of where NATO should beheaded and America's relation to the Alliance.

To bring an array of informed voices to the debate, four institutions - the Office of the Assistant Vice Chief of Staff of the U.S. Army, the Strategic Studies Institute of the U.S. Army War College, the Irving B. Harris Graduate School of Public Policy Studies of the University of Chicago, and the Program on International Security Policy at the University of Chicago — joined hands to sponsor a symposium titled The Future of U.S. Military Presence in Europe," held at the University of Chicago on 4 August 1999.

The present book is an outgrowth of this symposium. It is not designed to set forth a literal record of words and events in the mold of the traditional symposium "proceedings," but rather is organized as an anthology of individual chapters complemented by selected questions, answers, and comments by symposium participants and attendees. The symposium opening address by Deputy Secretary of Defense John Hamre (Chapter 1) and the keynote address by the Supreme Allied Commander Europe General Wesley Clark (Chapter 2) cogently set the stage for discussion. Chapters 3, 4, and 5 address the first panel topic, "Is Europe Still Strategically Important to the United States? Chapters 6, 7, and 8 tackle the second topic, Potential New Missions for NATO in the 21st Century, while Chapters 9, 10, and 11 are devoted to the last topic, What Type of Deployed Forces Does the United States Require to Meet Its Commitments in Europe? Noteworthy among the commentaries is the wrap-up by General Crosbie E. Saint (USA Ret.). As Commander in Chief of U.S. Army Europe during the period of the Gulf War, General Saint supplied the U.S. Army VII Corps, nominally slated as an element of NATO forces, to the coalition command that executed Operation DESERT STORM.



This book is concerned with the international regulation of non-state armed groups. Specifically, it examines the possibility of subjecting armed groups to international human rights law obligations.

First addressed is the means by which armed groups may be bound by international law. Of particular interest is the de facto control theory and the possibility that international law may be applied in the absence of direct treaty regulation. Application of this theory is dependent upon an armed group's establishment of an independent existence, as demonstrated by the displacement of state authority. This means that armed groups are treated as a vertical authority, thereby maintaining the established hierarchy of international regulation. At issue therefore is not a radical approach to the regulation of non-state actors, but rather a modification of the traditional means of application in response to the reality of the situation.

The attribution of international human rights law obligations to armed groups is then addressed in light of potential ratione personae restrictions. International human rights law treaties are interpreted in light of the contemporary international context, on the basis that an international instrument has to be applied within the framework of the entire legal system prevailing at the time of interpretation. Armed groups' status as vertical authorities facilitates the vertical application of international human rights law in a manner consistent with both the object and purpose of the law and its foundation in human dignity.

Finally, if international human rights law is to be applied to armed groups, its application must be effective in practice. A context-dependent division of responsibility between the territorial state and the armed group is proposed. The respect, protect, fulfil framework is adapted to facilitate the application of human rights obligations in a manner consistent with the control exerted by both the state and the armed group.

Daragh Murray's book analyses the practical and theoretical difficulties associated with the topic of the international human rights obligations of non-state armed groups by considering the latest developments in this field and suggesting ways forward. His proposals are realistic and carefully argued; this book should be essential reading for anyone grappling with this subject. 

The high civilian death toll in modern, protracted conflicts such as those in Syria or Iraq indicate the limits of international law in offering protections to civilians at risk. A recent conference of states convened by the International Committee of the Red Cross referred to 'an institutional vacuum in the area of international humanitarian law implementation'. Yet both international humanitarian law and the law of human rights establish a series of rights intended to protect civilians.

But which law or laws apply in a particular situation, and what are the obstacles to their implementation? How can the law offer greater protections to civilians caught up in new methods of warfare, such as drone strikes, or targeted by new forms of military organisation, such as transnational armed groups? Can the implementation gap be filled by the growing use of human rights courts to remedy violations of the laws of armed conflict, or are new instruments or mechanisms of civilian legal protection needed?

The chapters in Part 1 address key contested or boundary issues in defining the rights of civilians or non-combatants in today's conflicts. Those in Part 2 examine remedies and current mechanisms for redress both at the international and national level, and those in Part 3 assess prospects for the development of new mechanisms for addressing violations.

As military intervention to protect civilians remains contested, this volume looks at the potential for developing alternative approaches to the protection of civilians and their rights.

UN Peacekeeping is a complex endeavor resting on multinational partnership in strained contexts. Diverse national interests, doctrines, policies, and cultures come together in one operation to pursue common goals defined by the UN Security Council. They do so with usually ambiguous mandates and often find themselves operating in intricate environments. This is particularly true in the case of the United Nations Interim Force in Lebanon.

The UNIFIL has been deployed since 1978 in South Lebanon to prevent hostilities between Israel and non-state actors operating from the Lebanese territory. Over the decades, it has witnessed significant shifts in its security and political environments yet survived them. The Force and its mandate have been significantly strengthened in the aftermath of the 2006 war between Israel and Hezbollah. Its large contingent often draws from over thirty troop-contributing countries. Combined with a volatile political and strategic context, this diversity makes the UNIFIL a particularly interesting case to study the various challenges facing multinational peacekeeping.

This book brings together researchers and practitioners from various backgrounds, including from the two beneficiaries of the UNIFIL – Lebanon and Israel. Grounding their contributions either on first-hand experience or on fieldwork, the authors address a variety of issues affecting a peace mission such as the UNIFIL.

The first set of contributions investigates the defining features of UNIFIL's environment from different perspectives. The second set analyzes the multicultural challenges to the peace operation with a focus on European countries. The third one explores the rise of non-European countries. Overall, through the case of the UNIFIL, the various chapters weave a broad picture of today's peacekeeping, the challenges it faces, and avenues for the enhancement of its effectiveness.
